#### STATISTICS (sources & data can be found on page 2, or go to fentvic.org website under Resources Tab, NC County Fentanyl Reports and NC OCME reports)

- 80 fentanyl fatalities in last 9 years in Vance County (NC DPH Injury & Violence Prevention Branch, Epidemiology Unit)
- = 80 Vance County families permanently damaged by fentanyl
- 16,002 NC residents killed by fentanyl 2013-July 2023 (NC OCME)
- 8 more NC residents die each day from undisclosed deadly illicit fentanyl additives
- Fentanyl is #1 killer of NC and US residents ages 14-35 (CDC 2022) •

FENTANYL DEATHS IN VANCE AND ADJACENT COUNTIES (sources & data can be found on page 2, or go to fentvic.org website click Resources Tab, scroll down to NC County Fentanyl Reports and NC OCME reports)

- 92 fentanyl fatalities Franklin,
- 76 fentanyl fatalities Granville,
- 31 fentanyl fatalities Person,
- 80 fentanyl fatalities Vance,
- 21 fentanyl fatalities Warren,

= 300 fentanyl fatalities 2013-2022

2022 = 23 fentanyl fatalities 2022 = 21 fentanyl fatalities

- 2022 = 7 fentanyl fatalities
- 2022 = 17 fentanyl fatalities
- 2022 = 5 fentanyl fatalities
- 2022 = 73 fentanyl fatalities

# FENTANYL DOES NOT DISCRIMINATE!

- Victims do not know fake pills contain deadly fentanyl additives!
- Fentanyl kills babies, toddlers, middle and high schoolers, college students and young adults
- Fentanyl is #1 killer of NC and US residents ages 14-35 (source: CDC 2022)
